#### Legal Proceedings

On May 27, 2025, FOOD received the May 15, 2025 Notice of Entry of Judgment of the Court of Appeals Thirteenth Division certifying that February 20, 2025 Decision in FOOD's favor became final and executory on March 20, 2025.

The Decision stated that the 1,382,765,864 FOOD shares acquired by Strongoak, Inc. under the 2014 Private Placement and 2015 Stock Rights Offering, are exempt from the requirement of tender offer. Accordingly, the Decision dated December 15, 2022 of the Securities and Exchange Commission En Banc in SEC En Banc Case No. 07-22-501, was reversed and set aside. Judgment was rendered dismissing for lack of merit, the Complaint filed by Hedy S.C. Yap Chua, et. al., before the SEC Markets Securities Regulation Division in SEC MSRD Case No. MSRD-SRD-2021-1.

The Entry of Judgment in FOOD's favor, has no prejudicial impact on its business operations.
